Can you dismiss my Current Certiorari with the either Supreme Court or Court of Appeals please. I'm currently a level one and I have 2 yrs left on my sentence. I do not want to get more time. They want to try to give me a 20-30 or More Sentence with this introduction of the new charge they want to present to the Grand Jury if this Certiorari is granted and I win. My chances of Relief for Covid-19 Supreme Court order Contempt violating order for Web Ex procedures for Ineffective Assistance of Counsel my Attorney Jessica Saxon of Indigent Defense says Look good for Relief. But I'd rather the State Attorney General Office Take that Responsibility of Taking on the Court Docketts in each Circuit for Offenders that Did Web Ex and Correct or grant Relief for all inmates who were violated during the Pandemic by the Courts and the pre-trial lawyers and trial lawyers. They should investigate those Docketts and Transcripts! If they did and I know they want do it but then grant relief or retrials or some offer or plea or something then that may be better. But I don't want them pushing for more time on retrial. The Prisons in SCDC are filling up rapidly with

inmates who are getting long sentences. They have to have somewhere (a yard) for them to go to. 85% violent is packed. R&F is full overcrowded so I just got to Level one now. I'd rather stay where I am and not go forward with this Certiorari and get a retrial for more time. Imagine the State going Circuit to Circuit correcting the Docketts for Covid Order Violations how many inmates that may get relief or released. I'm sure they don't want to let people out of prison.

McMaster said that. Any violent offenders or 85% should remain in prison to serve sentences. I understand some people should be in prison. But everyone maybe not. Nobody is making ~~parole~~ parole at all that has a violent crime or non violent get parole. I'm not eligible but that with the increase in prisoners is why its overcrowding on these yards prison yards. Nobody is going home. Alan Wilson said he had over 11,000 cases to process why the reason he needs a Lawyer task force to help write briefs and ~~at~~ all at the Attorney Generals office those 11,000 are beds they need to fill prisoners that are on the way to prison. Not to mention the people who were not in the 10,000 who were charged they need beds and these yards have to open them. The SCDC needs to let some people go home. No just non-violent level ones inmates. Thats my opinion. I just want my Certiorari dismissed I do not want an increase in my prison time. They offered me a 10yr deal. I wanted 5yr and 5 probation
