Good Evening, Supreme Court I Antwain Littlejohn request an extension of time (30 days) to include ABC COURT REPORTING TRANSIP for December 19, 2024 hearing. I'm currently waiting for the status from this hearing where due to violation South Carolina Code 67-505 by the defendants non-comply with June 3, 2024 decision and order which instructed defendants to make weekly payments, continue medical treatment, medical expenses, until it is further order. So therefore I filed form 50 with South Carolina worker's compensation to address the matter at a hearing unfortunately even after the filing fee, I haven't been granted one. I filed the form 50 on December 15, 2024 four days before the form 21 hearing was held before the honorable Commissioner T. Scott Beck, which he stated to defendant where is the claimant benefits and that he already paid the defendants 150 days. Commissioner T. Scott Beck notify to claimant and defendants that since defendant stopped payments that the hearing would be premature to the order/decision June 3, 2024 so until the defendant are current to date with payments then there can be a proper hearing held for the defendants form 21. In addition the South Carolina Worker's Compensation have not given me an updated status about the hearing and order non-compliance. The South Carolina worker's compensation granted on December 31, 2024 a third hearing for form 21 to the defendants to be heard on March 05, 2025 which will determine if the defendants are current to date to stop payments which they are not; which leads for these hearings to get post pone to another date. I'm still waiting on commissioner T. Scott Beck to write an order/status from December 19, 2024
