Ms' Rischbieter told me 15 to 20 minutes before it was time to go in front of Judge Mc Masters that I was pleading to Voluntary Manslaughter 2. I didn't want to plea but she wasn't putting up no fight in my case!

I'm on trial for murder and she come see me seven times for thirty minute's or an hour. She would never let me see the evidence they had on me, I asked over and over for her to let me get my motion so that we can go threw it! Even the other lawyer that started working with her asked her why didnt she give me my motion and she

said that my motion was too big! The other lawyer Name was Meagon she's from the same Public Defenders office. They had multiple video's about my case she would always give me excuses of why she wouldn't show the other's. They got the "girl" who was "Jeremy lee" girl friend who took the gun off the scene and didn't charge her and she said that she got rid of the gun! She never put up no type of fight in my defence against the Solicitors, she would always say, "I didn't say nothing because I didn't want them to know where we stand!" She did that everytime and when we got a court Date she just wanted me to go ahead and Plea!

She told me 15 years then she said 18 years a month before the trial.

She called me down to the office at the court house and told me that I was Pleading to Manslaughter!

The defendant pulled a gun on me three times threatening my life, then his friend pushes me on the car and he puts the gun to my head and tell me he was going to kill me and it was too many people out there at the time! So a little time ~~done~~ passed that day and I see my neighbor who's birthday was that day we talk about what we going to do for his birthday. About 45 minutes after we talked my ride pulled up so I sent my son in the house and go talk to my ride about where were going, walk over to where my neighbor is and Jeremy is over there I didn't notice at first but when I got a little closer he just say "I should have shot you and your son while yall was sitting on yall car!" I was already scared from the incident earlier so I pulled my gun to tell him don't move but he was already pulling the guy next to him in front of him for a human shield.

After he pulled the guy in front of him
he shot me in the stomach! He let off one
or two more round's, I return fire and
he didn't live threw the wound's. I was badly
injured myself, I was in I.C.U. for 20 days
had to learn how to walk talk, just about
everything over again! I leaked out my gun
shot wound for 4 month's going to see the Doctor
or Nurse everyday for 130 something days.
I feel like this is a curse for me
living I just protected myself!
