Yes thank you and also the notice of hearing of the form 50 i submitted dec 18,2024 with the \$50 filing fee to be set that i haven't been mailed the notice letter from sc wcc commission stating a hearing was set March 05,2025 for my request and also i still haven't been able to receive a copy of the dec 19, 2024 form 21 hearing transcript from Abc court reporting pertaining to the defendants form 21 hearing have not been current to the June 03,2024 order decision for back pay for weekly benefits of periods November2023,December 2023,Jan 2024,February 2024,March 2024,April 2024,May 2024. Which Commissioner Beck questions defendants about the 150 days he paid the insurance to pay clamiant \$12,320 at the December 19,2024 hearing for the defendants was in violation when the weekly benefits started from june 03,2024 were stopped in November 06,2024 and November 27,2024 which the defendants are still missing a payment for 373.35 out of the 1,866 sent Jan 02,2025 for the five weeks defendants were behind ! The Defendants are now stating they have paid the claimant the benefits for out of work benefits but seem to can't provide the claimant with payment of history of with claimant signature along with the medical providers and i still yet have seen the payment history with signature of the checks that were cleared from defendant and i also notified Donald kamb on august 2024 before his release of counsel the only stubs i have received from defendant Mr Kamb couldn't provide me with the status ether and for the defendants send \$12,320 out June 06, 2024 for periods of out of work benefits to Donald kamb before his release of counsel and now defendant have sent an additional \$5,000 after his release on February 24,2025 which i haven't received anything from Mr Kamb and Mr Kamb abandoned the case before it was a final order and decision or settlement and should not be entitled to any of the claimants out of work benefits and medical providers fees because the medical provider \$4000 bill i have the defendant stating were paid have not yet been paid ether and now have sent the claimant bills to collections since september of 2024. So why would the defendants asked me for credit when the checks have been sent to my former attorney before and after the release of counsel on October 03,2024 a month before the wcc sc appellate panel made their final decision on the appeal for clamiant appeal for periods may 23,2023-nov06,2023 that was error through my former attorney donald kamb draft between mark allison and comissoner that stated him to draft the order So is mark stating for donald kamb to credit the checks back because the client (me) haven't recieved it along with the continuing medical treatment that should have been authorized by defendant insurance carrier,adjuster,or case worker.
