But I have received a check on December 31,2024 a check for 1,866.75 which would only be for the behind payment period for the month of 11/28/24-01/01/25 which should be corrected 2,240.10 and the continuing weeks failure to comply with section 42-9-60(g) shall result in a 25% penalty impose upon the carrier or employer computed on the amount of benefits that was withheld in violation of this section and the amount of the penalty must be paid to the employee in addition to the amount of benefits withheld the total amount of benefits 3,733.50

With the additional 933.37 is 25% of 3,733.50 should make the total lump sum 4,666.87 before you are current and up to date if you would please give me a reply or call back from the voicemail i have left you because the weeks ahead are continuing to be late as well it was said a check of 373.35 was sent out Jan 03,2024 but i still haven't yet to receive that check also and today's date is Jan 06,2024. As of today January 08 i receive a check for 373.35 that should have been sent on Jan 03 but 373.35 is still missing from the 1,866 check was sent December 31,2024. If Mark or Jenny Fogle can get in contact phone or email to resolve the error in the payment soon and Thank you.
