WHAT CONTENTS ARE LEFT IS MY LIFE'S WORKS.

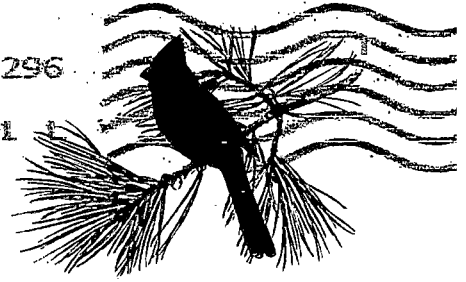
