Good afternoon,

I spoke with you briefly last week and Mr. Pierce called this morning and left a message. I cannot speak for Judge Kirven or Hutchens Law Firm and cannot provide legal advice, but I do know property is still on for the April 7<sup>th</sup> Sale in Oconee County. From what I understand this matter will not be withdrawn from the sale unless or until the statutory requirements for a stay on appeal are shown. I am not familiar with those requirements, so it is up to the Plaintiff's attorney to determine. If those requirements are met, the Plaintiff's attorney can pull from sale up until April 7<sup>th</sup> and even if sold, sale can be vacated.
