If I provided proof that from February 26th on from Goodwill CEO citania Jackson did they've asked the apartment complex for one form so that they can pay the rent full to the court and they peel Bond conditions would be met and that was well before the first and that by that evidence that you will see in that letter and that email sent book to your court and to all other courts

How can judge coble find me in violation of not paying the rent if the apartment complex willfully and maliciously did not provide the little bit of information requested on numerous occasions and by multiple means they would have been paid before the first well the court would have been

It's like they deliberately did it so that they could I would be violation

I'm on disability as a veteran only \$880 a month it shouldn't matter where the money comes from in this case Goodwill all means necessary and in good faith were made for this apartment complex to be paid and the appeal vondn conditions to be met

I can't be found in violation by law I guess if they in essence or refusing the money or refusing to provide necessary information

I hope it is evident at least to this court by my words my motion and the evidence provided that all means necessary were made to being complete cooperation and compliance by law with the appeal Bond set

Also as evidence to the court keep in mind that I've been under an appeal Bond since September 3rd the original being set by judge Michael Scott Richland county Magistrate And from September until January I was never found in violation for non-payment ever if you look in the records I I always have met the conditions of the bond as you will see in the records for 4 months rent was paid everything was good but now when judge coble reset it he set unreasonable expectations especially that don't harass part of it they harass me but due to that I ask that you find that I have been informed compliance that the apartment has been complacent and malicious and ask the court to find that their actions have caused the said violations equally

Again my life and my service animals lives are at stake

I trust this court will AGAIN find this writ unlawful

Toss it out and I will do whatever the court orders until we have our day in court as I did from Sept 1
