JOINT MOTION FOR LIMITED REMAND

Pursuant to Rule 240, SCACR, the Parties to this appeal hereby move for a limited remand of this matter to the circuit court. The parties have reached a tentative settlement in the case of *Covil Corporation, by and through its duly appointed Receiver, Peter D. Protopapas v. Pennsylvania National Mutual Casualty Insurance Company*, Civil Action No. 2024-CP-40-03014, which is currently pending on the asbestos docket managed by The Honorable Jean Hoefler Toal. If the settlement reached in 2024-CP-40-03014 receives court approval, all litigation currently pending between these parties, to include the matter currently on appeal, will come to an end.

The parties' tentative settlement agreement anticipates the filing of the within motion so that the circuit court can consider the Receiver's motion to approve the settlement and Penn National can seek vacatur of the March 1, 2024 order on appeal from the trial court.
