I believe this is what you are looking for. Please let us know if it something different. Thank you.

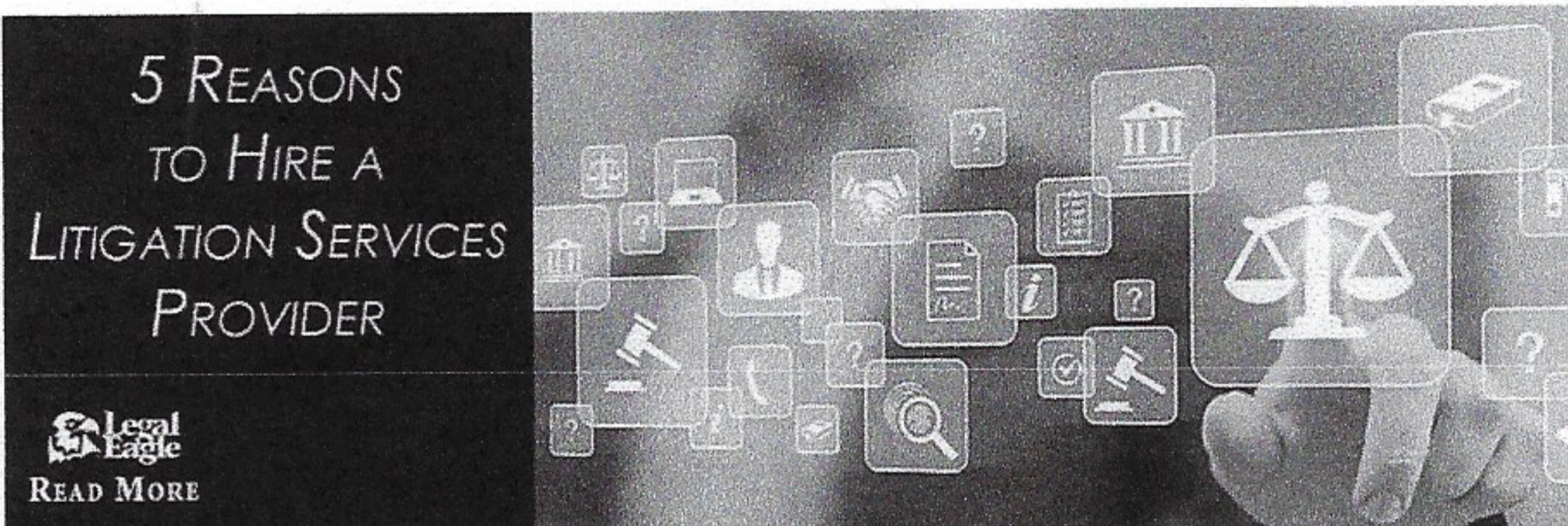
