This matter was dismissed with prejudice by the Honorable Daniel D. Hall, with an Order signed August 6, 2024. Following that dismissal, Wellpath, LLC filed for Bankruptcy in the United States Bankruptcy Court for the Southern District of Texas Houston Division. As this matter was dismissed, a Stipulation of Bankruptcy was not filed in the York County Court of Common Pleas.
