FROM COMMITTING A FELONY. HE REFUSED TO LOOK AT MY PROOF


OF CLAIM 3 TIMES AS HE HAD ME REMOVED FROM THE COURT (W -

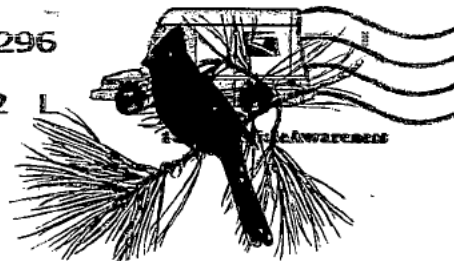
