

ORDER

On December 18, 2024, Appellant filed his notice of appeal from a circuit court order dated November 20, 2024. In his notice of appeal, he stated he received written notice of entry of the order on November 20, 2024. Appellant stated he served his notice of appeal on December 23, 2024. On January 10, 2025, we dismissed this appeal because Appellant failed to provide timely service of the notice of appeal. On January 25, 2025, Appellant filed a motion to reinstate the appeal. With his motion, he provided a copy of a notice of electronic filing (NEF) from the circuit court showing service of the notice of appeal by electronic filing on Respondent on December 16, 2024. Respondent filed a return on February 3, 2025, opposing reinstatement. Thereafter, Appellant filed a reply. After careful consideration of the filings, we reinstate the appeal. *See Eberly v. Advanced Flooring & Design Div. of ISI, LLC*, 442 S.C. 656, 660, 901 S.E.2d 273, 275 (2024) (holding "that automatic service of the NEF upon the E-filing of a notice of appeal constitutes proper service of the notice of appeal as to parties who are represented by counsel and proceeding in the E-Filing System").
