

ISSUE II

Also, be advised that I have been in prison for the past 15/16 years now. I have received only (1) teeth cleaning in 16 years. I have a front tooth that's very loose and four (4) of my teeth has been extracted due to decay from the denial of cleaning for 16 years in prison. I am in pain and it's discomfrantable for me to chew and eat food and drink. MY bottom teeth are dropping and are uneven on both sides. I need bracelets and such. I am preparing a lawsuit as I speak!

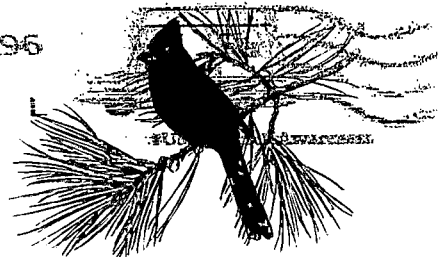
