This petition is in response to the Court's Order filed on March 6, 2025 and received by Appellant on March 11, 2025. Appellant argues that the Court issued this Order prior to review of the Appellant Reply to Respondent's Brief and the Appellant Response to Respondent's Motion to Dismiss which were filed in accordance with SCACR 208 and 224. Appellant will further argue that the issue of whether all DOC remedies were exhausted is still active and relevant. The ALC Judge ruled that Appellant had not exhausted his DOC remedies based on Respondent's response to the step-1 and step-2 grievances and his supposed failure to comply with SCDC Policy Adm. 15.13. Appellant has submitted in his "Reply and Response" copies of printouts from the automated KIOSK system that verify his compliance with Adm. 15.13. Appellant has also argued in the original brief that the ALC has ruled that an Agency policy cannot abrogate a statute of law, Sanders v SCDC. However Respondent has yet to submit any part of the record or issue a response to this procedural issue. ALC Judge Reibold issued his Order of Dismissal based solely on the step-1 and step-2 grievances. It appears to Appellant that without confirmation by this Court, on this issue, there is nothing to prevent the ALC from making the same ruling again. Therefore Appellant respectfully requests this Court to reinstate and rehear this case with consideration of Appellant's Reply and Response and this Petition.

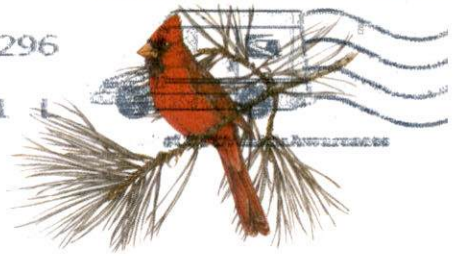
