
CRIMINAL SOLICITATION OF A MINOR

At a Court of General Sessions, convened on August, 2023,
the Grand Jurors of Lexington County present upon their oath:

That Mark Thomas Frick, on the date of August 12, 2021, did commit the crime of Criminal Solicitation of a Minor. To wit: Mark Thomas Frick, a person eighteen years of age or older, did knowingly contact and communicate with a person he reasonably believed to be under the age of eighteen, in Lexington County, for the purpose of or with the intent of persuading, inducing, enticing, or coercing the person to engage or participate in a sexual activity as defined in Section 16-15-375(5), or a violent crime as defined in Section 16-1-60, or with the intent to perform a sexual activity in the presence of the person reasonably believed to be under the age of eighteen. This is in direct violation of Section 16-15-0342, of the South Carolina Code of Laws (1976), as amended.
