




AFFIDAVIT OF COUNSEL
IN SUPPORT OF APPELLANTS MOTION TO ASSOCIATE
THE OFFICE OF INDIGENT DEFENSE FOR COSTS

I, Steven M. Hisker, was retained by to represent Mr. Robert Cimbollek in the trial phase of his Union County criminal charges of Murder and Possession of a Weapon During a Violent Crime. My retainer agreement stated that the scope of my representation ended after the trial and specifically excluded representation in any appeal or post conviction action.
