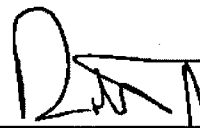

**ORDER ON DEFENDANT'S
MOTION TO RECONSIDER**

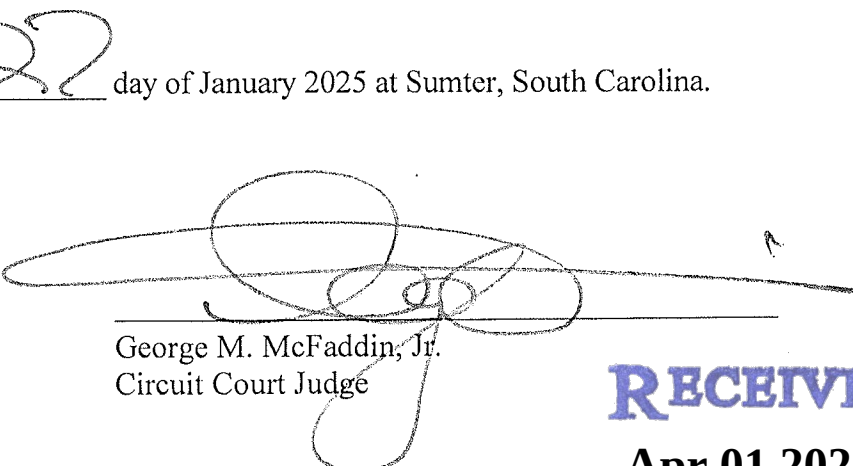
Defendant Charles Cavin Craft has moved for reconsideration of his sentences I imposed upon him on March 26, 2024. Defendant's able attorney filed the motion on April 2, 2024, and the motion was received at this office/chambers on December 18, 2024. I have reviewed the motion, the office file, and the sentencing orders, and I respectfully decline to alter, amend, or vacate the sentences.

Defendant could have been sentenced to a total of 58 years. I sentenced him to a total of 25 years with credit for time served of 901 days. Three of his sentences were concurrent for 5 years; two were consecutive 10 year terms. (10 plus 10 plus 5 for 25 years.) The sentences I imposes all fell within the statutory range of sentences. Further, it is within the discretion of the court to impose consecutive or concurrent sentences.

The sentences imposed do not, in any way, reflect any failing or dereliction of his very competent attorney.

Thusly, Defendant's motion to amend the sentences is respectfully denied.
