Personally appeared before me the affiant Jermaine Smith / C. Mizell who being duly sworn deposes and says that defendant Jesse Sebastian Broughton did within this county and state on or about 3/30/2023 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Colleton) in the following particulars:

DESCRIPTION OF OFFENSE: Drugs / Manuf., poss. of other sub. in Sch. I, II, III or flunitrazepam or analogue, w.i.t.d. - 2nd offense

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on March 30, 2023 at approx. 2250 hrs. Deputy conducted a traffic stop on a Toyota Camry NC Tag for traveling 94 mph in a 60 mph zone within Colleton County. The defendant, Jesse S. Broughton, was the driver of the vehicle. Deputy Smith could smell the odor of marijuana coming from the vehicle. A probable cause search was conducted and discovered a clear bag containing a quantity of marijuana which weighed 230 grams underneath the driver seat. The bag also contained 15 empty packets used for packaging. The defendant had \$8,190.00 on his person, which is consistent with sale and distribution. Broughton's criminal history indicates he was convicted of PWID Marijuana 1st in 2016. This act violates Title 44, Chapter 53, Section 370 of the SC Code of Laws. The above is true and believable, based on the personal observations and investigations of Deputy Smith, who is a witness to prove the same in such case made and provided against the peace and dignity of the State of SC. 23-1086
