Dear Ms. Kitchings,

Please find enclosed a copy of SCDC Form 15-1 which I submitted to the Tyger River Mailroom on March 26, 2025. It has been returned and marked as highlighted in the upper right corner as needing an attachment. Highlighted in the lower right of the form is the prohibition of any such attachment. This has been an ongoing problem here at Tyger River of late. We are being told an attachment is required when SCDC Policy clearly prohibits it (Adm.15.12, 7.9) and yet no form for such an attachment is provided nor is anyone in the mailroom able to provide a description of such a form. I have been able to convince the mailroom to send in my requests previously and may again be able to do so. SCDC Policy Adm. 15.12, 7.8 states that payments directed by State or Federal Courts will be honored and SCDC Policy GA.01.03, 17 states that inmates are required to pay filing fees pursuant to all S.C. State Court and Federal Court rules. The only exceptions to SCDC Policy concerning attachments is when making donations to religious or charitable organizations (Adm. 15.12, 7.6).

Please except my explanation for the delay in receiving the filing fee for the **Petition for Reinstatement/Rehearing** in the above case.

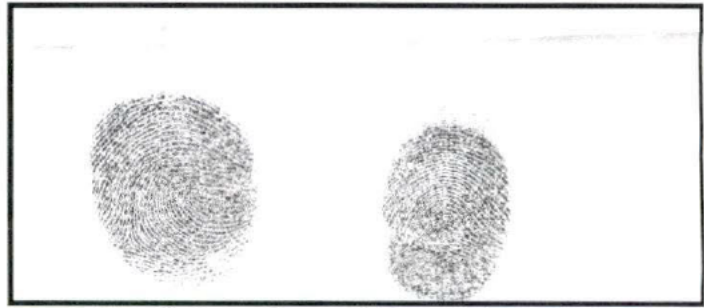

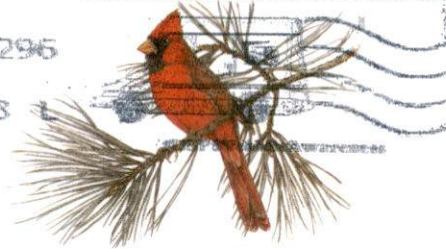
