
Dear Ms. Harrison:

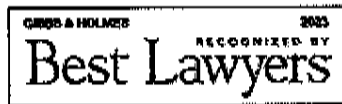
