On March 28, 2025, Respondents Certain Underwriters at Lloyds, HDI Global Specialty SE, and General Security Indemnity Company of Arizona (“Insurer Respondents”) filed an Unopposed Motion for an Extension of Time with the Court which sought not only an extension of time for the Insurer Respondents to file their Initial Respondents’ Brief and Designation of Matter to be Included in the Record on Appeal, but also a reciprocal extension of time for A. Tebele & Sons and Crescent Coast Insurance, LLC to submit their Initial Respondents’ Briefs and Designations in the primary and cross-appeals.

The Court’s Order issued on April 4, 2025 only granted an extension to the Insurer Respondents. We believe it may have been an oversight of the Court to not include A. Tebele & Sons and Crescent Coast Insurance, LLC in this Order. Therefore, the parties respectfully request that the Order be amended to provide that A. Tebele & Sons and Crescent Coast Insurance, LLC also have until April 14, 2025 to file their Initial Respondents’ Briefs and Designations.
