FIRST OF ALL, THERE IS NO APPEAL OF MY FORECLOSURE. THERE WAS AN APPEAL TO STOP THE FORECLOSURE. THE FORECLOSURE ORDER IS IN DIRECT VIOLATION OF THE U.S. BANKRUPTCY ~~ORDER~~ ^{ORDERS} SIGNED BY THE CHIEF JUSTICE OF THE SOUTH CAROLINA BANKRUPTCY COURT. YOU CAN FIND HER ORDERS IN PACER UNDER 20-03558-HB, 20-80034-HB, AND ~~ANOTHER~~ ORDER SIGNED 3/10/25 WHICH MAY BE IN PACER NOW.

WITH THAT SAID, YOU AND MS KITCHINGS, IN MY OPINION ARE DEMONSTRATING "DELIBERATE INDIFFERENCE", CIVIL CONSPIRACY, AS YOU BOTH SEEMED DETERMINED TO GIVE ME THE FACTS OF EVIDENCE THAT PROVE YOUR ATTEMPT TO PREVENT ME RECEIVING DUE PROCESS.



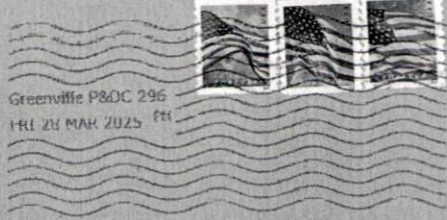

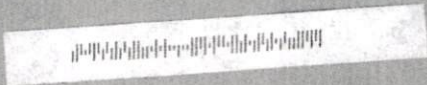
