RE: CONSTITUTION VS RULES

MS KITCHINGS & MS. HARRISON,

I WANT BOTH OF YOU TO UNDERSTAND MY PERSPECTIVE AS I HOPE TO DO MY PART IN MAKING AMERICA BETTER.

MY FATHER, AS MY GRANDFATHER, SEEMED TO ALWAYS KNOW WHAT TO DO REGARDLESS OF FAITH. I NOW REALIZE THAT THOSE TWO MEN DID WHAT WAS "RIGHT" REGARDLESS OF COST OR CONSEQUENCE. THOSE TWO MEN TAUGHT ME TO OBSERVE THE LAWS OF THE STATE OF SOUTH CAROLINA. THE LAWS OF THE UNITED STATES OR

AMERICA. TO DO WHAT WAS "RIGHT" BY MY FELLOW MAN. I HONOR MY FAMILY AS THEY TAUGHT ME RATHER THAN INSTRUCTED ME. MY FAMILY, EVEN MY GREAT AUNTS AND UNCLS, SEEMED TO LIVE BY THE GOLDEN RULE REGARDLESS OF "RELIGION".



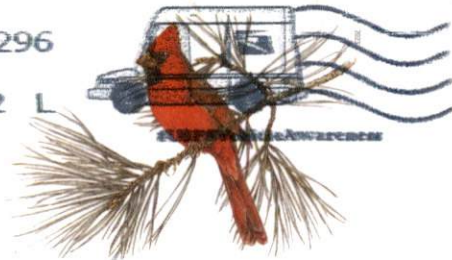
