I have stated so many times that, I have tried to resolve this before going before Magistrate Court, Beaufort Circuit Judge and Appeal court. I found excessive errors on lease. There was errors of clerks of court with evidence. That could have be avoided and could prevented going to court and having to appeal. I feel like this was done out of insensible intent from Beaufort Housing Authority.

I would like to express I experience greater disadvantage, burden, discrepancies with having to prove one-sided unfairly dealing in this legal matter. The Beaufort court affirm with Magistrate Court. It was major delay with gaining court recorder reports from Beaufort County Circuit Court due having to find the reporter from Mr. Holmes and still be transfer to another reporter causing another timely costly delay. Also Magistrate court reporter charged me three times, for copy of reports on USB drive totaling to \$45, which is unfair, because then when I tried to submit my evidence on USB drive to COA, it was returned stating that it has to be on CD. So how is right for Magistrate COURT to place court report/evidence and charged \$45 that I have paid and have receipt for \$45 worth of USB drive submitted to COA.

Also due to low income below poverty lines,

I have tried to apply to Sc legal aid and other legal representative of low country and they stated would either be absent a week prior to court date Beaufort Circuit County or the case will be unsuccessful, or too complex, I even had other lawyers to me give up because it's area wouldn't find help . I face disadvantage, unfairly,biased while trying to navigate through legal system, while urgent emergency hardship circumstances that was evident in court findings. Also due to low income and below poverty lines which evident in this case, It hard for me to find legal aid for Legal representation.

BHA provided Lease into evidence to the original Magistrate Court case, I resubmitted and highlighted errors and overpayments.
