NOTICE OF APPEAL

WILLIAM DONALD BOLT appeals his conviction and sentence in this case. Mr. Bolt was convicted after a jury trial and the sentence was imposed by the Honorable Donald B. Hocker on September 6, 2013. This appeal is taken from the order of the Honorable Donald B. Hocker, dated September 18, 2013, which denied appellant's motion for new trial. Appellant received notice of entry of this order on October 4, 2013, after checking the records of the Clerk of Court for Greenwood County.

Pursuant to S.C.R.App.P. 203(d)(1)(B)(iv), the issues raised during trial and in Appellant's Motion for New Trial which are reviewable on appeal are the following:

1. Whether the court erred in instructing the jury to "seek the truth" in its preliminary instructions;
2. Whether the court erred in denying Appellant's directed verdict motion on the charge of Lewd Act on a Minor;
3. Whether the court erred in denying Appellant's motion to open fully on the law and the facts and use final argument for rebuttal only;
4. Whether the court erred in admitting Appellant's statements into evidence;
5. Whether the court erred in denying Appellant's request that the jury be charged that reasonable doubt is the type of doubt that could cause a person to "hesitate to act."



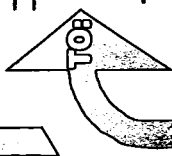
