**MOTION FOR EXTENSION OF TIME
TO FILE INITIAL REPLY BRIEF**

Pursuant to Rule 263 of the South Carolina Rules of Appellate Procedure, Appellants Patricia P. McGougan and Edgar McGougan move for a 30-day extension of time to file the reply to Respondents Richard F. Frisch, M.D. and The Southeastern Spine Institute, L.L.C.’s (“Southeastern”) initial brief. The current deadline is April 14, 2025, and the proposed extended deadline would be May 14, 2025. This is Appellant’s first extension request for this brief and is based on efficiency and judicial economy considerations.
