




However, I did not intend to file a motion to amend the Record on Appeal. I prematurely filed the twice-revised Record on Appeal due to my misunderstanding of the Court Order granting Respondent's first Motion to Strike and requiring Appellant to submit a Remanded Record on Appeal, issued on January 31. As a pro se appellant, I thought this Order also granted Respondent's second Motion to Strike filed on December 9, 2024, to which Appellant submitted a Response in Opposition on January 30, 2025. The revised Record on Appeal included all the documents

requested in Respondent's Second Motion to Strike. In addition, I filed the Appellant's Final Brief based on the twice-revised Record on Appeal.
