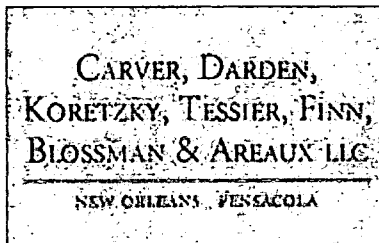

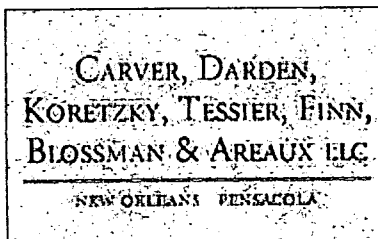

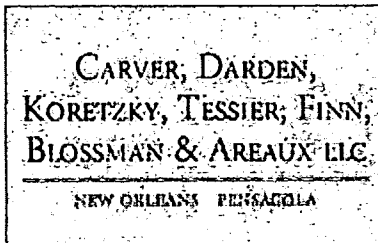

I looked at your website and noticed that you were a member of the SC Bar. I presume she got your information through them.

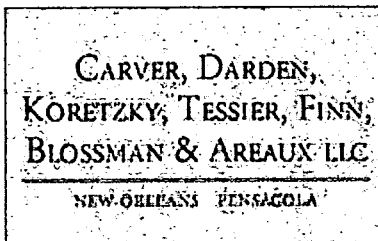
It was interesting to hear from you. I have never met another John Dunlap before.
