Dear Mr. Lagroon:

On March 6, 2012, I received a letter from you dated February 18, 2012, requesting the Transcript of Record in the above listed matter. I replied with a letter dated March 7, 2012 acknowledging that I was the court reporter for this hearing and I requested a check in the amount of \$45.50 in order to type this for you. I have yet to receive a check from you for that amount and so I have not typed this transcript. I am attaching a copy of my first letter for your reference. I have now received a second letter from you requesting this transcript dated September 18, 2013. I received it on September 27, 2013.

As stated in my first letter, Rule 607 provides that the rate of \$3.25 shall be charged per page for a transcript and I estimate it to be 14 pages long. Based on the current rate, the estimated cost of this transcript will be \$45.50. Upon receipt of your check in the amount of \$45.50, I will be able to place your request in line for typing.
