

**MOTION FOR EXTENSION OF TIME FOR APPELLANT TO REQUEST
TRANSCRIPT**

Appellant United States of America acting through the Rural Housing Service or successor agency, United States Department of Agriculture (hereinafter “Appellant”) by and through its undersigned counsel, respectfully requests a 30-day extension of time to request the transcript of the final hearing in this matter which was conducted by Webex before the Honorable Alan D. Clemmons, Master in Equity for Horry County on October 8, 2024. Outside of the Record of Hearing filed October 7, 2024, there is no transcript currently available for the October 8, 2024 hearing or the continuation thereof which was held open pending compliance with Judge Clemmons’s requests and no further hearing was conducted prior to the issuance of the Judgment of Foreclosure and Order for Sale issued February 10, 2025 which is the subject of this appeal. There was also no hearing prior to the Order Denying Motion to Reconsider, Alter and/or Amend filed March 12, 2025.

The Appellant believes the Record of Hearing filed October 7, 2024 in the Office of the Clerk of Court for Horry County along with a transcription of the Webex hearing contains a complete record of the hearing that took place that day. Appellant's counsel is in the process of obtaining a copy of the October 8, 2024 Webex hearing and will be submitting the same to a Court Reporter upon receipt.

The Notice of Appeal was filed on April 10, 2025 and Appellant's counsel was out of town on vacation April 16, 2025 through April 21, 2025, and he was not able to make the appropriate request for the Webex recording due to a scheduling conflict.




