Dear Clerk of the Court,

I, Richard N Thames the appellant in the above-mentioned case, respectfully request a Motion to Reinstate for the following reason:

I did not receive the transcript that I requested and paid for through Legal Eagle that they received on January 31, 2025.

I had been out of the state for nearly 2 months and received a letter on March 19, 2025 from the court during that time informing me that I had failed to inform the court that I didn't receive the transcript. I called the court and left a voicemail with my information for a call back. I did not receive a call back. I then called the Court Administration office and spoke with Cordelia Coath. She emailed Legal Eagle on April 15, still nothing from Legal Eagle. I called Legal Eagle and spoke with Kevin who put me through to Velvet Mills (transcript manager) voice mail. Ms. Mills sent me an email on April 17 stated that my request for my transcript is due back April 23. After several attempts I finally spoke directly with Ms. Mills and asked her why I never received my transcript in a timely manner, she informed me that she never saw that I had paid for it. Although I had sent a money order for the transcript in January.

I have provided emails from all correspondence with Legal Eagle. Their failure to send my transcript prevented me from advising the court of the status of the transcript.
