Personally appeared before me the affiant Lee Garbo for Anthony Raines who being duly sworn deposes and says that defendant Timothy Carson Ryder did within this county and state on or about 02/01/2012 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Pickens) in the following particulars:

DESCRIPTION OF OFFENSE Domestic/Criminal Domestic Violence; 3rd offense within 10 yrs.; or 2 prior convictions of any combination of 16-25-0020 within 10 yrs. (formerly CDR 685)

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

The defendant, Timothy Carson Ryder, did on 02/01/2012 offer or attempt to cause physical harm or injury to his wife, Erica Lynn Ryder, with apparent present ability under circumstances reasonably creating fear of imminent peril. The defendant was intoxicated and became irate when the victim asked him to go to bed. The defendant then threw a glass beer bottle at the victim narrowly missing her. He then charged at her but a witness stepped between him and the victim. The witness and another person wrestled the defendant to the ground outside the residence. They eventually released him and the defendant ran into the residence threatening to obtain a gun and kill the victim. The defendant has three prior convictions for Criminal Domestic Violence dated 9/21/2004, 9/12/2005, and 02/25/2008 making this a 3rd or subsequent offense. 1. PCSO Incident Report # 2012-02515. 2.
