COMES NOW Appellants Saint Matthews Healthcare, LLC; Melissa Kizer; and Melissa Davis, by and through their undersigned counsel, and, on the grounds set forth below, hereby move this Honorable Court (a) to grant them leave to file/serve the within motion, out of time, to extend the time for filing/serving their initial brief and designation of matter to be included in the record on appeal; and (b) to grant them a first extension of 30 days' time.

The undersigned counsel ordered two transcripts relating to this appeal on February 24, 2025. The first transcript was received on March 3, 2025 and the second transcript was received on March 12, 2025. Through inadvertence, the email with the second transcript was overlooked and therefore the undersigned never notified the court of the transcripts' receipt, or calendared the time to file/serve the initial brief or otherwise move for an extension of time, which ran on April 11, 2025.

With apologies to the Court and opposing counsel for this oversight, the undersigned humbly submits that good cause exists to grant the relief requested herein, which relief, the undersigned submits, is in the interests of justice and will not cause any undue prejudice to Respondent. The undersigned would assure the Court that the aforementioned oversight was simply the result of inadvertence and by no means reflective of any intentional disregard for the proper appellate process.

In the 19 years in which the undersigned has regularly practiced in this Court, it has been his experience that the Court has generally graciously allowed parties two extensions of the time for most deadlines. Notwithstanding the unusual way (procedurally speaking) in which it is being sought herein, in terms of actual time, the Court's allowance of the additional time requested herein (which is, ultimately, an extension of time through May 12, 2025) keeps this appeal on the

same schedule as it would have been on had Appellants timely requested a first 30-day extension on April 11, 2025.

Besides the foregoing explanation of the aforementioned oversight, the additional time requested herein is being requested because of other time commitments (work-related and non-work-related).

Wherefore, the undersigned hereby moves this Honorable Court (a) to grant them leave to file/serve the within motion to extend, out of time, the time for filing/serving their initial brief and designation of matter to be included in the record on appeal; and (b) to grant them a first extension of 30 days' time to May 12, 2025. Moreover, the undersigned asks that the Court hold Appellants' initial briefing deadline in abeyance until it rules upon the foregoing requests for relief.
