
The Zip Code he listed is incorrect as the correct Zip code is 29646.



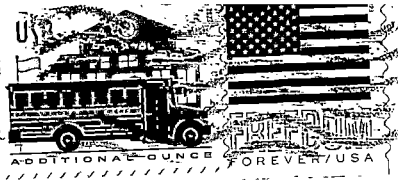
