**MOTION TO REQUIRE APPELLANT TO SUBMIT ANOTHER CORRECTED
RECORD ON APPEAL**

On April 4, 2025, Respondent submitted a motion to require the Appellant to submit a corrected record on appeal based on the fact that the record he submitted did not contain the documents listed in each party's designation of matter. More specifically, the record submitted by Appellant did not contain any documents at all. In response, Appellant submitted a Record on Appeal containing the materials he listed in his designation of matter, but not containing the material listed in Respondent's designation. Respondent listed the following in its designation of matter: "Order of Dismissal from the ALC dated August 2024."

The Record on Appeal fails to contain all documents required by Rule 210 (c), SCACR. Therefore, Respondent cannot prepare a proper Final Brief with correct record references to the ALC order. Accordingly, pursuant to SCACR Rule 210(c), Respondent respectfully requests that this Court require Appellant to file another corrected Record on Appeal containing the documents designated by both the parties. Respondent further requests that this Court hold the time period for any filings in abeyance pending resolution of this motion.


