The trauma of having to not be able to receive mental health treatment for all the pain & rage that prevents me from sleeping at night, Records Show that I have Been Homeless Since this case & placed in a mental Hospital 3 times I am attempting to let go & settle But because of My skin Color & Mental disabilities I am Forced to do everything alone while dealing with Emotional distress Hood law firm feels they will get away with this but while I am spending years to get a trial I will be billing Hood law firm & the City of Hanahan \$1000,00 per day and I will be seeking a Judicial investigation on all Councils involved while I fight this case in District Court & the Supreme Court.

The **plaintiff**/Appellate is Forced to represents myself pro se While hood Law firm has all the South Carolina Attorneys & Judges under their Control they Are Above the law with complaints about Deadlines that are not met Because of their Conflict of interest.
