



2. 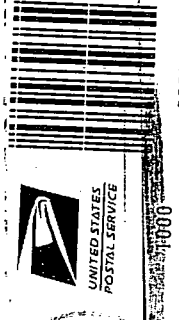
