NOW COMES Respondent Rebecca Hagood, as Personal Representative of the Estate of Frank D. Chavis, Sr., by and through her undersigned counsel, pursuant to Rule 263(b), SCACR, as well the Court's order of July 16, 2014, and moves for an extension of an additional ten (10) days to file/serve Respondent's Return to Petitioners' Petition for a Writ of Certiorari.
