This letter is in response to your request for a review of your parole file regarding the parole hearing conducted on February 26, 2025.

According to your review, you disagree with a parole revocation that took place 08/30/2017. Further investigation revealed that the revocation is incorrectly attributed to a new conviction in the Examiner's summary; however, the Prior Supervision History does accurately indicate the supervision was revoked due to technical violations.

The parole file has been modified, and your case was presented back to the Board for reconsideration on April 9, 2025.

The Board's review ended with their decision to uphold their decision to deny parole. The reasons and the vote count remain unchanged.

Please note, there is no rehearing/appeal process for the routine denial of parole.


