**APPELLANT’S MOTION FOR EXTENSION OF TIME TO RESPOND TO MOTION
TO DISMISS APPEAL**

Pursuant to South Carolina Appellate Court Rule 263(b), Appellant Bayerische Motoren Werke AG respectfully requests an extension of time to respond to Respondent Linda K. Reker’s Motion to Dismiss Appeal (“Motion to Dismiss”).

Respondent filed her Motion to Dismiss on May 6, 2025. Pursuant to South Carolina Appellate Court Rule 240, Appellant’s return is due on May 16, 2025. The undersigned counsel for Appellant is currently participating in a trial in the U.S. District Court for the District of South Carolina. The trial is scheduled to conclude on May 16, 2025—the day Appellant’s return is due. Appellant therefore requests a ten (10) day extension of its deadline to file a return. Should the Court grant this motion, Appellant’s return shall be due on May 27, 2025.¹
