Counsel had an oral argument in the case of Lindy Lamont Jones v. The State before the Court of Appeals on March 5, 2025. Counsel filed the brief of appellant, designation of matter and supplemental record on appeal in the case of The State v. Mack Gaines with the Court of Appeals on March 3, 2025.




