2. Counsel will file the Anders brief of appellant and record on appeal in the case of State v. Derrick L. Tuten with the Court of Appeals today, May 12, 2025. Counsel filed the petition for rehearing in the case of State v. Michael Mobley with the Court of Appeals on May 8, 2025.


Counsel had an oral argument in the case of State v. Matthew S. Young in the Cour of Appeal on April 8, 2025. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Jackie Ray Childers v. State with the Supreme Court on April 4, 2025. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Darrell Green v. State with the Supreme Court on March 21, 2025. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Wallace Demery v. State with the Supreme Court on March 17, 2025. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Reynoldo Pimienta v. State with the Supreme Court on March 14, 2025. Counsel had an oral argument in the case of State v. James E. Daniels in the Supreme Court on March 11, 2025. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Jacob Hall with the Court of Appeals on March 7, 2025. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Rasheed Robinson with the Court of Appeals on March 3, 2025. Counsel filed the petition for rehearing in the case of State v. Shanekia Garvin with the Court of Appeals on February 13, 2025.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that her caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


