
Motion for Costs

The Respondents Courtney Gamble, Spencer Josey, Elizabeth Ann Geddings, Cecil L. Josey, Jr. as Trustee of the Josey Family Trust move this Court, pursuant to Rule 222(d), SCACR, to tax costs on appeal in the amount of \$1062.15 against the Appellant Stanley D. Josey.

Pursuant to Rule 222(a), "costs shall be taxed against the appellant when the appeal is dismissed or judgment on appeal is affirmed." Rule 222(d) further provides that: "A party desiring costs to be taxed shall, within fifteen (15) days of the issuance of the remittitur, serve and file a motion requesting that costs be assessed under this Rule."

In support of this motion, the appellate records will show unto the Court that the Supreme Court issued its opinion on July 14, 2010, affirming the trial court's order of partition on September 11, 2013; the Appellant Stanley D. Josey has not petitioned for rehearing; and the Remittitur was issued on September 27, 2013. The Respondents are submitting an Itemized Statement of Costs herewith for \$59.75 in printing costs for the Final Brief of this Respondent and the standard \$1000.00 attorney fees allowed.


