MOTION FOR SECOND EXTENSION OF TIME TO FILE INITIAL BRIEF

Appellant, Steven Maness respectfully moves this Court for an additional thirty (30) days to file the Initial Brief in the above-captioned appeal. In support of this motion, Appellant states as follows:

1. Appellant's initial brief is currently due on **May 19, 2025**, following a prior 30-day extension granted by this Court.
2. Within the past week, Appellant has been treated for post cancer complications/chronic pneumonia, which has significantly impaired his ability to complete/finalize the brief. Medical documentation can be provided upon the Court's request.
3. Additionally, while finalizing the brief, Appellant discovered at least **two material transcription errors** in the hearing transcript relevant to the summary judgment proceedings. These errors affect the accuracy of the record, relate directly to the root cause of mechanical failure presented and require further clarification or correction before proper legal argument can be presented in the context of the hearing in question on September 6, 2024.
4. This request is made in good faith and not for purposes of delay. Appellant seeks this additional time to ensure that the brief is complete and accurate.
5. Appellant has reached out to the court reported regarding this issue.
6. Appellant respectfully requests that this Court grant an **additional 30-day extension**, making the new due date **June 19, 2025**.



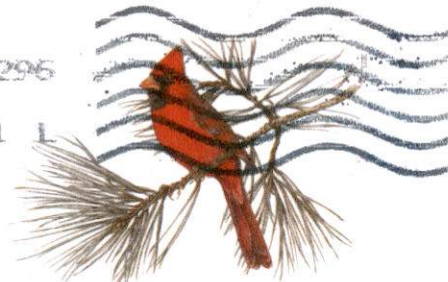
