MOTION FOR LEAVE OF COURT TO PROCEED INFORMA PAUPERIS AND NOTICE OF APPEAL

Now Here comes John S. Stritzinger, Appellant who has been approved to file without fees in the lower court and asks for the same permission in this court with a reference as attached. Nothing materially has changed since the original filing.
