NOTICE OF APPEAL

Prisma Health (“Prisma”) appeals the order issued by the Honorable Vernon F. Dunbar filed on May 7, 2025. Prisma received notice of the Court’s order on May 7, 2025. A copy of the circuit court’s order is attached hereto for filing.

This appeal involves the circuit court’s issuance of an order compelling Prisma to produce medical records in two pending criminal cases—*State v. Francisco Lobos Lobos*, 2024A2330206283; 2024A2330206285; 2024A233030686 and *State v. Emily Laneshia Jocquisha Dawkins*, 20222351034126; 20222351034128; 2024GS2307112A; 2024GS2307113A.

This appeal involves a single order that applies to two pending criminal matters; therefore, Prisma respectfully requests the Court consolidate the two pending appeals into a single appellate case.

In conjunction with this appeal, Prisma is filing a Petition for Extraordinary Relief including a Writ of Certiorari with the South Carolina Supreme Court pursuant to Rule 245(b), SCACR. Additionally, Prisma filed a Motion to Reconsider with the circuit court pursuant to Rule 29 and Rule 37 of the South Carolina Rules of Criminal Procedure. However, Prisma files this Notice of Appeal to avoid any doubt as to its intent to appeal the circuit court's order and its right to move the circuit court to reconsider its order. Prisma will notify the Court when it receives the circuit court's decision on that motion.


