DESCRIPTION OF OFFENSE: Domestic / Domestic Violence, 1st degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about December 22, 2019, the defendant, Odis Reeves Rhoden, did physically assault the victim by striking her with the butt of a shotgun once on her left arm and one on her left thigh. She was struck on her right eye twice and three or four times to her head. During the assault, Rhoden pointed the shotgun at her. The defendant and victim do cohabitate together, great bodily injury was likely, and a firearm was used during the commission of the assault. Bruising and swelling were observed and photographed. This incident did occur in Jasper County and is in violation of the South Carolina Code of Laws as Amended.
