
Respondent requests a thirty-two-day extension such that the filing will now be due on Monday, June 30, 2025. The filing fee and original copies of this motion has been deposited in the



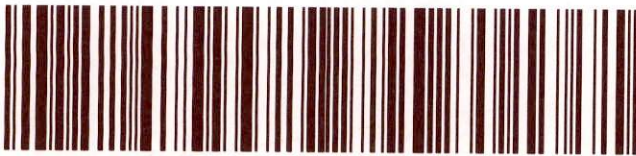
