NOTICE OF APPEAL

Please take notice that OHM Florence, LLC d/b/a Thunderbird Country Buffet (“OHM” or “Appellant”) appeals the Order of the Honorable Haigh Porter, Master-in-Equity, dated May 15, 2025 and denying OHM’s April 24, 2025 Motion to Alter or Amend Pursuant to Rule 59(e), Or, in the Alternative, Motion for Relief from Judgment Pursuant to Rule 60(b) (attached hereto as **Exhibit A**), regarding Judge Porter’s prior Order of Judgment filed April 14, 2025 and corresponding Form 4 Order of the same date, following a hearing on March 31, 2025.
